

**AMERICANA TOWERS CONDOMINIUM
POOL RULES AND REGULATIONS
SUMMER SEASON 2010**

1. Use of the Americana Towers Swimming Pool and the adjoining Sun Deck Area is limited to Building Residents and their guests and is subject to strict compliance with the following rules, such additional rules as the Board may approve from time to time and all applicable governmental laws, particularly Illinois Department of Public Health rule 20.00 of the Minimum Sanitary Requirements for the Design and Operation of Swimming Pools and Bathing Beaches.
2. All persons swim at their own risk at all times, notwithstanding the presence of an attendant. The Association does not accept any responsibility and will not be held liable for any injury to any person or theft or damage of any property in the swimming pool area.
3. Access to the swimming pool requires either a swimming pool membership card or a guest membership card. The Board will determine on an annual basis the membership fee and will establish procedures for procuring cards. Each resident will be notified prior to the opening of the swimming pool of such procedures. **NO DAILY PASSES AVAILABLE.**
4. No person is permitted in the pool area when it is closed.
5. Weather and other conditions permitting, the swimming pool will be made available to residents and their guests for a period beginning on May 29 and concluding September 6, from 10:00 a.m. to 8:30 p.m. daily.
6. Each person in the swimming pool area must obey the directions and orders of the attendants. Report any accident or injury to the attendant on duty immediately.
7. The swimming pool may not be reserved for private parties at any time, nor may any resident having a swimming pool membership card be denied access to the swimming pool by anyone other than management or an attendant having good cause to do so. Places on the deck may not be reserved.
8. **Alcohol is strictly prohibited at any time in the swimming pool area.**
9. **All glass, food, and/or gum of any kind whatsoever are strictly prohibited at any time in the swimming pool area, (per the Department of Health Swimming Pool Code, Section 820.360 c).**
10. Mattresses, floats, balls, and other similar objects are prohibited in the swimming pool area.
11. Radios, CD's and tape players may be brought to the swimming pool area, provided they are listened to through headphones.
12. **Children under sixteen (16) years of age will not be permitted in the swimming pool area unless accompanied by an adult** responsible for them. Non-swimmers must remain in the shallow end of the pool, and there is to be no running in the pool area.
13. All persons with long hair are required to wear bathing caps.
14. Pets are not permitted in the pool or sun deck areas. Baby carriages are not permitted in the pool area.
15. The freight elevator should be used when dressed in pool attire.
16. Smoking is strictly prohibited.
17. All children who are not toilet-trained shall wear tightly fitting rubber or plastic pants, (per Department of Health Swimming Pool Code Section 820.360, j).
